

REGULAR MEETING OF THE CUYLER TOWN BOARD

May 11, 2023

Present were: Supervisor Randall, Clerk Custer, Councilwomen Corbin and Stafford, and Councilmen White and Smith. Superintendent Breed

Also present were: Deputy Supervisor L Smith, Alan Fink, Matthew VanWagenen, Chris Crossway, and Aiden Mower.

Supervisor Randall led the Pledge of Allegiance and the regular board meeting was called to order at 7:00pm.

On a motion from Councilwoman Corbin and seconded by Councilman White the board approved the minutes for April 13, 223.

She stated that the contract was already approved thru the Legislators and it is good for one year and he will see what can be done.

On a motion from Councilwoman Corbin and seconded by Councilwoman Stafford the board voted to accept the snow plowing contract.

Superintendent Breed also stated it would cost about \$58 thousand to finish Oil Mill road. He thinks Suite Kote would be the cheapest.

Supervisor Randall also stated she has updated the highway policy.

Superintendent Breed stated that he has been trying to reach Aaron Pforter to get some plumbing done at the highway garage. He also would like an eye wash machine put in.

Dog report read by all board members.

Justice Fink stated he has been busy. He will try and get some parking tickets with no dates on them.

No code enforcer report.

Aiden Moyer from Equity Solar was at board meeting to discuss solar on Route 13.

Supervisor Randall stated that the town's attorney is reviewing the contract.

Supervisor Randall will advise when she hears from our attorney.

Supervisor Randall asked the board if they wanted to pass a temporary town wide moratorium on the installation of wind energy conversion systems.

On a motion from Councilman Smith and seconded by Councilwoman Stafford the board to do a temporary town wide moratorium.
